Description: Repair parts and assemblies for railcar destination signs manufactured exclusively by Teleweld, Inc., as required, for a period of 36 months

Change Order No. 1 provides for an additional \$80,000.00 to replace existing signs on the 2600 series cars that are being moved to the Blue Line as the 5000 series trains replace existing Red Line trains. The contract was expended sooner than expected due to a large number of destination signs that were changed during the Wells Street Bridge project to alleviate confusion for customers.
