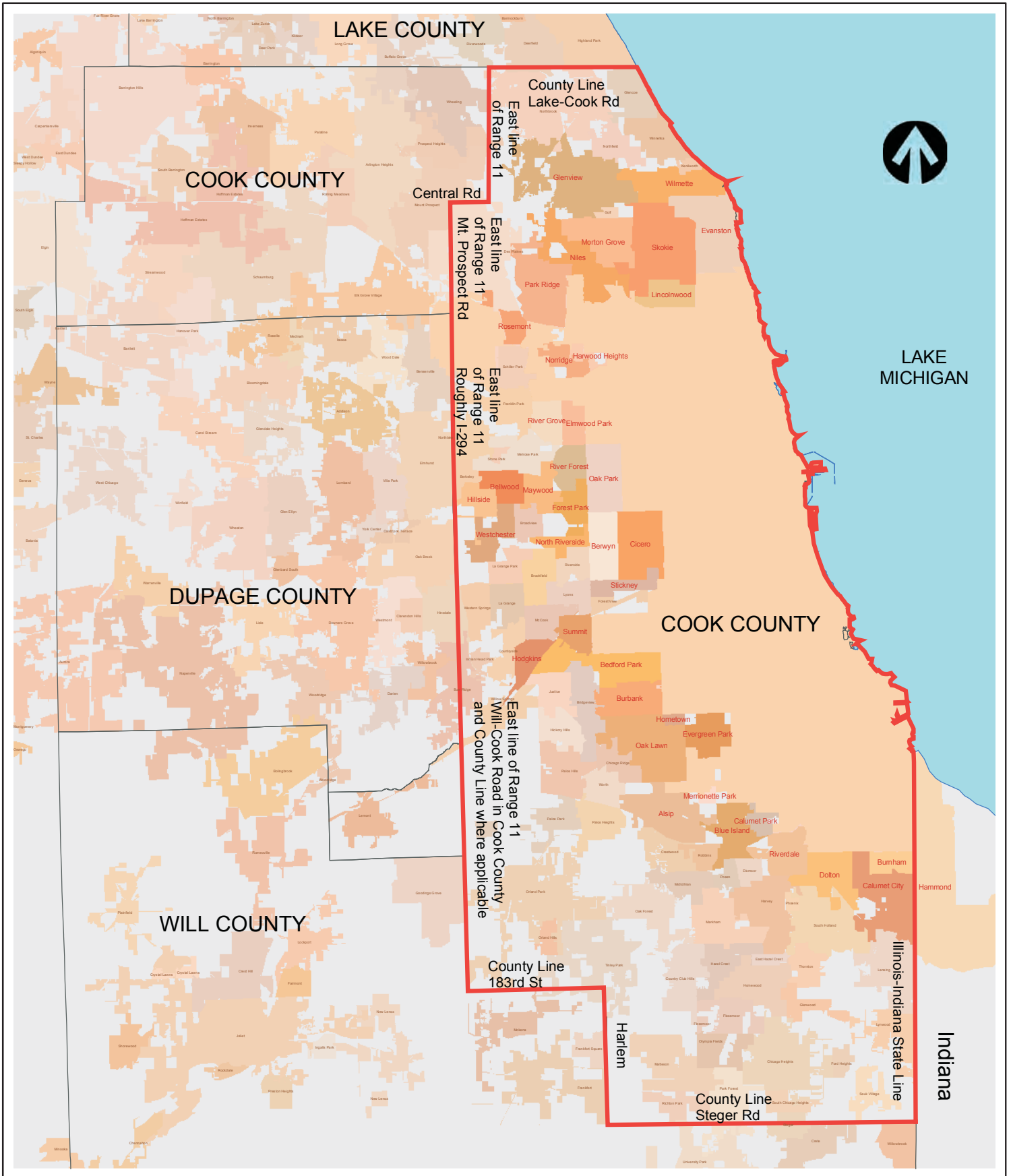


CTA Statutory Service Area with Suburbs Served
